 - a. Discussion and/or Action as Necessary: Discussion from previous meetings on the current structure and future structure of the North Prairie Police department. Further discussion regarding the public information meetings on the 24th of June at 10am, 2pm and 6pm: During the discussion on the upcoming public informational meeting regarding the North Prairie Police Department, the committee decided to move the originally planned date of June 24th due to an impractical mailer turnaround time. A new target date of July 16th was selected, with July 14th as a backup depending on room availability. The meeting will be held at 10:00 AM, 2:00 PM, and 6:00 PM, and the committee agreed that each session would begin promptly. If no attendees are present within five minutes of the scheduled time, that session will conclude. The committee established that approximately three weeks should be allowed from finalizing content to the arrival of the mailer in residents' mailboxes--one week for printing and delivery, and two weeks for residents to review the material prior to the meeting. A half-sheet flyer will be mailed to all addresses in the Village, including businesses, to ensure widespread awareness. Informational packets will be made available at the meeting and will include a 4-5-page handout summarizing key data such as patrol coverage, citation counts, police presence in surrounding communities, and potential options for North Prairie's policing future. Additionally, a sign-in sheet will be used at each session to document attendance, with a resident of North Prairie volunteering to oversee the process to ensure legibility and completeness.
