Discussion/action as necessary on background check, drug test results, physical and the recommendation by Chief Dan Nottling regarding the hiring of Evan Von Hoffman as a Cadet for Kettle Moraine Fire District: Chief D. Nottling read his recommendation to the Fire Commissioner regarding the hiring of Evan Von Hoffman. Motion by B. Hehn to hire Evan Von Hoffman as Cadet for the Kettle Moraine Fire District. Motion seconded by A. Mull. No further discussion. All in favor. Motion carried.

Discussion/action of Kettle Moraine Fire District exit interviews: B. Taylor wanted to have this added to the agenda. He was wondering if it was within the Fire Commissioners means to do exit interviews or does it need to be done through the Fire Board. R. Spurrell stated that if exit interviews were to be conducted by a governing body, then by protocol they should be done by the Fire Board. He stated that if someone was leaving under duress and they wanted to appeal then it would be brought to the Commissioners. R. Spurrell also stated that if the Fire Commissioners conducted the exit interviews then it could be seen as not an unbiased process if the Fire Commissioners did the exit interviews. Motion by B. Taylor that we recommend to the Board to come up with a process to do that. Motion seconded by B. Hehn. No further discussion. All in favor. Motion carried.
